



LIMITED TEN YEAR WARRANTY SERIES 1500 ALUMINUM DOUBLE HUNG WINDOW

Subject to the terms and conditions stated herein, Silver Line Building Products Corporation warrants the Series 1500 Aluminum Double Hung Window to the original purchaser as follows:

1. Aluminum extrusions and finish are warranted to be free from manufacturing defects in material and workmanship for a period of ten (10) years. The finish will not blister or peel within this period. During this period, if a part is found to be defective, replacement part(s) will be supplied at no charge.
2. All mechanical parts are warranted to be free from manufacturing defects in material and workmanship for a period of ten (10) years. If a part is found to be defective during this period, replacement parts will be supplied at no charge.
3. Under conditions of normal use and service, insulating glass units are warranted to be free of obstruction of vision as the result of dust or film formation on the internal surfaces caused by failure of the hermetic seal due to faulty manufacture for a period of ten (10) years. Should the insulated glass fail under this warranty, Silver Line will assume 100% of the glass cost during the warranty period. The forgoing warranty applicable to insulated glass units will be void under the following circumstance: (1) Damage during handling or installation; (2) Subjection to stresses arising from heat application causing temperature differentials over the glass surfaces and/or stresses caused by building settlement or movement. **THERE ARE NO WARRANTIES, EXPRESSED OR IMPLIED, AS TO GLASS WHICH IS BROKEN BY ANY CAUSE OR REASON.** Condensation on the external surfaces of the window, which may occur as the natural result of humidity and/or interior/exterior temperature differentials, is not a defect and is not covered by this warranty. Minor blemishes that do not impair the structure or visibility of the glass are excluded under this warranty.

This limited warranty is transferable from the original purchaser to one subsequent property owner. Written notice of transfer must be sent to Silver Line no later than thirty (30) days after transfer accompanied by a \$35.00 transfer fee and a copy of the original invoice for the windows covered under this warranty. Failure to do so will relieve the manufacturer of any further obligation hereunder.

The foregoing warranty covers only manufacturing defects as specified herein and will be void under any of the following circumstances: Defects or damages resulting from handling, faulty installation, normal deterioration, accidents, fire, floods, acts of God, vandalism, abuse, neglect, failure to perform reasonable and necessary maintenance, improper application for the design of the product or building settlement or movement.

Under no circumstance is Silver Line to be liable for incidental or consequential damages including, but not limited to damage or loss of other property or equipment. The warranties set forth herein are expressly in lieu of all other warranties expressed or implied including warranties of merchantability and fitness for a particular purpose and all other obligations or liabilities on the manufacturer's part. This warranty covers material only and Silver Line does not assume any expense involved with removal or reinstallation of replacement parts. In the event that Silver Line's obligation under this warranty is sought, the part(s) which allegedly do not conform to this warranty must be shipped to Silver Line, transportation charges pre-paid. Silver Line will, at its option, repair or replace any defective part(s) or component(s) without charge, excluding glass (see glass warranty).

The original warranty period shall not be extended by any repair or replacement and the remaining warranty time period shall continue in effect.

Silver Line reserves the right to discontinue the model manufactured under this warranty, or change any component of the same and shall have the right to substitute a different model, part or component designed by Silver Line, to be equal quality or price. Color variance may occur between original weathered material and replacement part(s) which does not indicate a defect.

If any part of this warranty shall be held void or unenforceable in any State of the United States, the remaining portions shall nonetheless continue in full force and effect. This warranty is applicable only to windows installed in the continental United States.
